DECLARES

- 1) to have carefully read the documents published at <https://www.uniroma1.it/it/node/229407>, concerning the correct behaviors to be observed in Sapienza for the purpose of preventing the spread of COVID-19 and to undertake to follow all the indicated recommendations and procedures;
- 2) to have measured today's body temperature, before access to the premises of the Faculty of Engineering of Sapienza, and to have verified that **it is less than 37.5 °C (99.5 °F)**

LEGAL BASIS FOR TREATMENT

Art. 6(c) of European Regulation No 679/2016: the performance of a task of public interest or linked to the exercise of public authority by the data controller

SCOPE AND DESCRIPTION OF THE TREATMENT:

Data are processed, in compliance with the current regulatory framework, by the Employers, the Security Office and the Centre for Occupational Medicine in order to:

- protect the health and safety of workers in the workplace;
- monitor the risk of the spread of infectious diseases, and in particular of COVID-19 infection;
- collect the necessary information for COVID-19 risk management in the workplace;
- transfer to the Italian National Health Service, exclusively following a written request, any data relating to potential contacts at risk of infection that have occurred in Sapienza.

The data will be used exclusively for the institutional purposes and within the provisions of laws, regulations or contractual rules.

NATURE OF THE PERSONAL DATA STRICTLY NECESSARY TO PURSUE THE DESCRIBED OBJECTIVE

Common personal data: first name, last name

Particular categories of personal data: health data (body temperature, presence of flu symptoms, in particular, cough, cold, sore throat, burning eyes, difficulty in breathing).

ARCHIVING AND RETENTION

The data will be stored (in paper and digital format) for a time interval as long as necessary to achieve the aforementioned purposes, in accordance with national and European legislation (EU General Data Protection Regulation).

NOTES ON THE RIGHTS OF THE INTERESTED PARTY

The interested party can ask the data controller, if relevant conditions permit, to access to personal data pursuant to art. 15 of the Regulation; the amendment of the same data pursuant to art. 16 of the Regulation; the deletion of the same data pursuant to art. 17 of the Regulation (where the latter does not conflict with the current legislation on the retention of data and with the need to protect, in the event of legal disputes, the University and the professionals who have processed it), or the limitation of the processing pursuant to art. 18 of the Regulation, that is, it may object to the data processing pursuant to art. 21 of the Regulation, in addition to being able to exercise the right to data portability pursuant to art. 20 of the Regulation. In case of violation of the provisions of the Regulation, the interested party may complain to the Guarantor for the protection of personal data, according to current Italian legislation.

Part 2.

All users must strictly comply with the following provisions:

1. wash your hands frequently using soap and water for 40 seconds, alternatively use hydroalcoholic solutions;
2. avoid touching your eyes, nose or mouth with your hands;
3. when coughing and/or sneezing, cover the mouth and nose with the elbow recess or with a tissue, avoiding the contact of the hands with respiratory secretions;
4. throw the tissue once used and wash your hands immediately after;
5. avoid promiscuous use of bottles and glasses;
6. avoid hugs, handshakes and direct physical contact;
7. inside the premises always wear surgical masks, avoid close and prolonged contact with people and keep a distance of 2 meters (where not possible at least 1 meter);
8. outside the premises, when in white zone, wear surgical masks if it is not possible to continuously maintain a distance of at least 2 meters;
9. wear FFP2 masks for extraordinary activities in which it is necessary to continuously maintain a distance of less than 1 meter;
10. on the way to and from Sapienza, whether using public transport or by car with other non-cohabiting people, it is necessary to wear a face mask continuously.

Access to vending machines is allowed complying with the following indications:

1. avoid assemblages;
2. sanitize the hands before accessing the consumption area through the gel dispensers placed outside the area;
3. consume what is taken away from other people;
4. access the vending machines area one person at a time.
